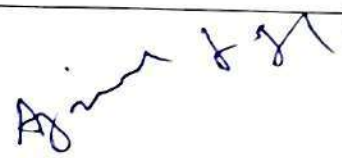

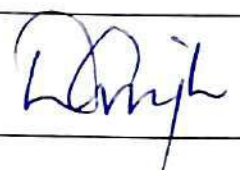

Dhillon (Vice-Chancellor, Guru Kashi University, Talwandi Sabo, Bhatinda)

General Observations

- The parking area should be reorganized to offer more parking spaces to the students
- Up gradation of Reading room
- College should be eco friendly by managing dry and plastic waste separately.
- NSS activities should work in tandem with local bodies by collaborating more with them
- Syllabi for bridge courses and remedial courses should be updated

Significant Achievements

I Curricular Aspect

- One new certificate / diploma courses i.e Life skill was introduced during this academic year.
- Ten students were enrolled in certificate/ diploma courses.
- One new postgraduate program B.Ed.-M.Ed 3 Year Integrated was introduced with 50 seats.
- One value added course i.e. Personnel Management was introduced during this academic year.
- Twenty students were enrolled in Personnel Management course.
- Feedback from students, alumni and parents had collected to help the individuals and organization as a whole, to improve the performance and effectiveness.

II Teaching Learning and Evaluation

- Demand ratio of college program is higher in comparison to seat availability.
- Two hundred and ninety five applications received for B.Ed. course amazed availability of 200 seats.
- In this academic year, two hundred eighteen students were enrolled in Undergraduate Program and twenty- six in Postgraduate Program.

- College is getting sufficient support from the management for academic and infrastructural development.


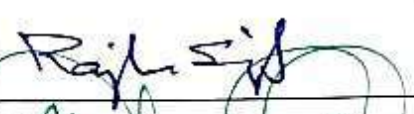
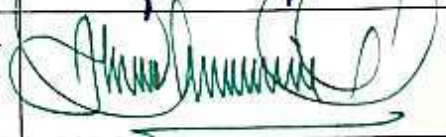
VII Best Practices

VII Best Practices

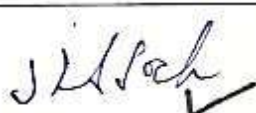
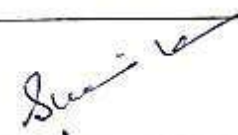
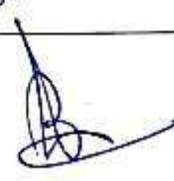
- One of the notable best practices of our college is the efforts to “Strengthening Ties with the Community” to cultivate a sense of social responsibility in the students and inspire them for community service.

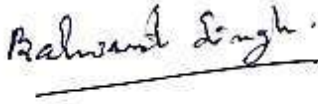

VII Best Practices

IV Infrastructure and Learning Resources

- The college campus is spread over 61,997.6 sq mts (over three blocks) of land, is equipped with modern and functional workspaces and create an excellent ambience and atmosphere for teaching-learning.
- There are 8 well equipped laboratories and 4 Resource Centres, two well-equipped seminar rooms and two multipurpose halls.
- The college is equipped with net+ (bandwidth 40Mbps to 100Mbps)-unlimited and BSNL (10Mbps till 10GB) Broadband unlimited Internet connections.
- The college library is partially automated with “E-governance” software and operates under the “Open Access System” which gives a user friendly interface to its users for searching resources in the library
- The college has subscribed services of National Library and Information Services Infrastructure for Scholarly Content (N-LIST) under ID 7797, which is jointly executed by e-shodhsindhu consortium, INFLIBNET Centre and INDEST-AICTE consortium.
- There is an open gymnasium in the college campus.
- The college has live recording studio for developing e-content.
- Adequate budget is sanctioned every year by the management of the college to ensure the maintenance and augmentation of physical, academic and support facilities.

v Student Support and Progression

- The institution organizes various career oriented programmes and personal counseling sessions which instill much needed confidence in students' and give impetus to the performance not only in academic but also in other activities in the curriculum.
- The institution organizes various skill-set and capability development programmes to equip students to work under different working environment.
- The grievances related to students encompassing complaints related to sexual-harassment, ragging, fee related, psychological complaints etc. are addressed proactively through transparent mechanism by inviting grievances by online and offline modes.
- Specialized programmes on student's awareness are also arranged.
- Students avail financial help, accommodation at reasonable rates and concession in fee (tuition/hostel).
- The placement cell acts as launch pad for students by holding skill development, career guidance programmes as well as campus drives for opening job opportunities.

VI Governance, Leadership and Management

- College entails participative management by the Governing Body, the Principal, the teaching and non-teaching staff and the students.
- There is a well-defined hierarchy in the college. The Principal is the decision-making authority for the college.
- Coordinators of different courses and faculty members execute the curricular aspects.
- A strategic plan for three years is prepared and academic calendar is prepared in tune with the strategic plan
- The college has various committees such as Grievance Redressal Committee, Anti-Ragging Committee, Minority Cell, OBC cell, etc.

- The college maintains transparency in its financial, academic and administrative functions.
- E-governance measures are adopted in admission, fee collection, staff attendance, all types of correspondence and many others. The office is increasingly becoming paperless.

VII Best Practices

- The institution is highly conscious and firmly determined in addressing the environmental issues judiciously. Green practices and Energy conservation practices are given highest priority to create eco-friendly rules in the campus.
- Rooftop Solar PV System, LED lights, TFT/LCD Monitors, Energy efficient Electrical Appliances are used to minimize its energy consumption.
- Green Audits are conducted to assess the performance of the institution in green initiatives and to promote environmental consciousness among students.
- Minimum use of plastic bags, tree plantation drives, workshops on best out of waste, carpooling, use of ceramic and steel utensils and promotion of print little are some initiatives taken.
- All wastes are disposed of through proper waste segregation mechanism. Vermi-composting is done to use Biodegradable Waste.
